

Alaska's unemployment rate showed an expected seasonal increase in December, climbing to 5.8% from November's rate of 5.6%. The December rate is three-tenths of a percentage point lower than in December 2000 and substantially lower than both ten-year and twenty-year averages. The comparable national unemployment rate rose from 5.3% to 5.4%

The number of unemployed persons climbed by approximately 600 persons to 18,649, a 3.3% increase from November and a 4.3% decrease from year-ago levels. Initial claims for unemployment fell by more than 300, a 3.8% decrease. Initial claims for the year are down by more than 5,000, a 5% decline from total initial claims in 2000.

Alaska's continued low unemployment rates and moderate employment growth suggest that the state's economy remains healthy, according to Dan Robinson a labor economist with the Alaska Department of Labor and Workforce Development.

Regional unemployment rates throughout the state also followed seasonal trends. Southeast Alaska saw the biggest increase, jumping from 6.2% in November to 7.3% in December. Every borough and census area within the region saw an increase of at least four-tenths of a percentage point, with Juneau recording the smallest increase, moving from 4.3% in November to 4.7% in December.

The state's most populated areas continue to register lower unemployment rates than rural areas. For the second month in a row, Anchorage had the state's lowest unemployment rate, unchanged over the month at 3.7%. Fairbanks saw a minimal increase from 5.1% to 5.2%, and the Mat-Su Borough registered a December rate of 6.7%, up from November's 6.3%. In comparison, the highest rate in December was in the Wade Hampton Census Area at 14.9%. Both Bristol Bay and Kodiak Island Borough saw high rates in a month when a lull is expected in fisheries employment.

Preliminary estimates show that wage and salary employment declined by about 4,000 jobs over the month. The state has added more than 5,300 jobs since December 2000, an increase of 1.9%. The service industries, retail trade, and government account for most of the growth.
